A Review of Heart Failure Guidelines Updates:
What Pharmacists Need to Know

This session will focus on the new update to the heart failure guidelines that were released earlier this year. There are some important medication recommendations that have been added or changed and pharmacists will be updated on these changes. Also the presentation will focus on the treatment algorithm released in the guideline update so they can assist with medication recommendations to providers and counsel patients on any new medications. *Pharmacists will be able to outline the updated medication recommendations found in the heart failure guidelines; explain the role of sacubitril/valsartan and SGLT-2 inhibitors in the treatment of heart failure; and examine the treatment algorithm for patients with Stage C HFrEF found in the update to the guidelines.*

Pharmacy Technicians will be able to describe ODMAP's principle users; describe the benefit of implementing statewide ODMAP usage; and identify the participants in the current Louisiana ODMAP pilot program.*

sent out through two pharmacy organizations. The study revealed that pharmacists are knowledgeable about naloxone, however stigma and knowledge about opioid use disorder as a disease state still exist. *Pharmacists will be able to describe the perception of pharmacists regarding opioid use disorder (OUD) and harm reduction; describe potential strategies to bridge the gap knowledge for pharmacists regarding OUD; and determine action steps you are going to take to provide better care to OUD patients.*

Discovering Diabetes Devices**

This session is to give pharmacists and pharmacy technicians a basic understand of these devices and pharmacy’s role in dispensing. *Pharmacists will be able to compare current insulin pumps and glucose monitoring devices; introduce smart pens for insulin delivery; outline key patient counseling points for devices; and advise care team of device data integration. Pharmacy technicians will be able to describe current insulin pumps and glucose monitoring devices; describe the use of smart pens for insulin delivery; outline key patient counseling points for devices; and assist care team with device data integration.*

New Antimicrobial Agents: Wading into the Waters of Appropriate Agent Use**

This session will focus on the appropriate use of new antimicrobial agents in select patient populations, allowing pharmacists and pharmacy technicians from all backgrounds to more appropriately utilize new antimicrobial agents. *Pharmacists will be able to identify new antimicrobial agents, their mechanisms of action, and spectrum of activity; analyze the primary literature surrounding the use of each agent identified; and develop an appropriate patient specific treatment plan given a patient case. Pharmacy technicians will be able to identify brand and generic names of new antimicrobial agents, and match each antimicrobial agent with its niche in practice.*

340B—Is It for ME?**

This session is an overview of the 340B Program and its potential impact on a pharmacy. The session will cover the origins of 340B, program procedures, risks and benefits and operational best practices when entering a 340B partnership. Pharmacists will be able to explain the fundamental basics and potential benefits of a 340B program, discuss the importance of the negotiated 340B Dispensing Fee, identify key components of the Pharmacy Services Agreement, and explain the flow of funds in a typical 340B arrangement. Pharmacy technicians will be able to explain how a 340B contract can help the community, discuss the requirements for healthcare organizations to be eligible for 340B, and identify key roles pharmacy technicians play in assisting the pharmacist with managing a 340B program.
